INSTRUCTIONS

1. In a large pot, combine all ingredients and bring to a boil, stirring occasionally.
2. Reduce heat immediately after boiling to low and let simmer slowly as you serve the wine.

INGREDIENTS

2 bottles red wine (pick a good everyday wine, not too robust - save the expensive wine for your meal, but pick something drinkable.)
1 cup brandy or applejack
1 cup orange juice
Half an orange, sliced thin
4 cardamom pods
2 sticks of cinnamon
4 star anise
6 cloves
1/2 cup cranberries, optional

How Much is My Case Worth?

Various self-help websites frame the answer by this formula: three times the medical bills plus lost wages. That answer is, however, misleading and should not be used.

The best way to maximize your interest is to work with an experienced attorney. An attorney can use investigators to gather evidence, medical records and witnesses to build your case to a value that accounts for all medical bills and lost wages, including those in the future.



FACTORS THAT DETERMINE THE VALUE OF YOUR CASE.

There are a many factors that determine if you have a case and what it's worth. Remember that every case is unique and the questions your attorney will ask you will be tailored to your specific situation. Here are some basic questions most car accident lawyers will likely ask:

- What are your injuries?
- Did you need surgery, or will you need it in the future?
- Do you have unpaid medical expenses?
- Were you, or are you still, unable to work?
- Do you have lost wages?
- How long did it, or will it, take for you to recover?
- Do you have permanent damage or scarring?
- Were there any witnesses to your accident?
